

## Homeless Situations

- \* Place not meant for habitation  
(e.g., a vehicle, an abandoned building, bus/train/subway station/airport or anywhere outside)
- \* Emergency shelter, including hotel or motel paid for with emergency shelter voucher, or RHY-funded Host Home shelter
- \* Safe Haven

## Institutional Situations

- \* Foster care home or foster care group home
- \* Hospital or other residential non-psychiatric medical facility
  - \* Jail, prison, or juvenile detention facility
  - \* Long-term care facility or nursing home
- \* Psychiatric hospital or other psychiatric facility
- \* Substance abuse treatment facility or detox center
